Guy announced it was time to review the election results.

Congratulations and welcome new board members, Peter Shaw and Vinny Zicolello

Jim Campbell congratulated the new members. Jim stated that the yearend financials were posted on the website. As of 9-24-21 we had \$362,000.00 in the bank. In 2019 when we took over, we had \$30,000 in the bank. With early payment of dues, we were able to operate from 10-19 till 6-21, 21 months with a negative balance of \$44,988.00. This will be the first year we will be able to meet our financial obligation and we are projecting a \$50,000.00 reserve. We are planning a financial review from a third-party auditing firm from our inception to

end of fiscal year 6-31-21. We will continue developing annual budget reports and report a quarterly budget variance.

Guy thanked Jim for his report. At this time Guy opened the floor for comments and questions.

Both Vinny and Peter thanked everyone for their support.

Question on combining lots:

Liz stated: anyone buying a lot from Vista auction can combine lots. \$250.00 fee with no limit and pay one dues. if not combined or adjacent \$125.00 for a vista lot purchased at the sale.

Guy stated we are looking to extend to existing lot owners. Please petition the board for review.

Jim Campbell stated he was looking at the listed lots to see who owns the adjacent lots. He commented on the possibility of doing something as a group. Also mentioned the auction was Nov. 5, at 10:30 on the courthouse steps.

Question, how do we operate without a budget?

Calhoun answered, we work off the existing budget till new budget is ratified. Should be in the next few weeks, then there will be a meeting to ratify.

Question: is there a deadline on merging lots?

Not at this time.

Question, possibility of a secure website

Calhoun stated that they are working on that now with new software.

Question, to Calhoun, do you have any clients using electronic voting?

Not at this time.

Question, is the POA looking to buy the lots on the left side of the guard house?

Looking at all options.

Jim stated that the POA owns about 20 lots now and are available if anyone is interested.

Liz stated if anyone is interested in any lots, send a request to Riverbendpoaboard@gmail.com

Question, can we assemble a group of lots and present to the county.

Recommend submit to board to formulate a list.

Question Calhoun, working with other POA's do you have examples of volunteer committees and committee charges or best practices rather than starting from scratch.

Question, any update on the letter sent to Brian Gaines

We received a proposal from Mr. Gaines. We will distribute to new board members for review and keep the community informed.
